

The Saraland City Council convened in special session on April 8, 2019, at the Saraland Municipal Annex meeting room. The meeting was called to order at 6:03 p.m. by Council President Joseph McDonald. Roll call was as follows:

City Attorney, Andy Rutens, was present.

Councilmember Cromer opened the meeting with prayer.

Council President McDonald advised the purpose of this meeting is to discuss an application for a carnival permit. Other municipal business may be considered at this time.

Motion was made by Councilmember Biggs, seconded by Councilmember Cromer, to approve the carnival permit. Motion carried.

Councilmember Biggs introduced the ordinances approving the amendment of Section 12-22 and Section 12-32 of the City of Saraland Municipal Code.

ORDINANCE 1134

BE IT ORDAINED by the City Council of the City of Saraland, Alabama that Section 12-22 of the City of Saraland Municipal Code be amended.

Section 12-22 of the Saraland Municipal Code currently reads as follows:

Section 12-22. - Frequency of Collection.

Garbage shall be collected by the city from each location twice per week. Trash shall be picked up by the city from each location once per week.

It is the decision of this Council that Section 12-22 of the City of Saraland Municipal Code shall be amended to read as follows:

Garbage shall be collected by the city or the city approved service provider from each location twice per week. Trash shall be picked up by the city or city approved trash service provider from each location once per week.

ORDINANCE 1135

BE IT ORDAINED by the City Council of the City of Saraland, Alabama that **Section 12-32 of the City of Saraland Municipal Code shall be amended.**

Section 12-32 of the Saraland Municipal Code currently reads as follows:

Section 12-32. - Rates and charges.

- (a) The charges for the city garbage and trash pickup shall be established by the governing body.
- (b) Each subscriber to the city garbage services shall pay his garbage bill within ten (10) days of the date such bill is mailed. If such bill is not paid on time, the city shall have no obligation to pick up garbage or trash from such location.

Exemption: Any Saraland resident may apply to be exempted from the city's garbage/trash service if their primary residence is greater than seven hundred fifty (750) feet from the public right-of-way. This is contingent on the resident obtaining permission from the Mobile County Health Department authorizing an alternative waste disposal method for said residence and subsequent approval of the Saraland City Council.

State law reference - Power to fix and collect fees for garbage disposal, Code of Ala. § 11-47-135.

It is the decision of this Council that the wording of this Ordinance should be altered to properly reflect the provisions contained in the current city garbage and trash service contract. In furtherance of this determination, Section 12-32 of the City of Saraland Municipal Code is amended to read as follows:

Section 12-32. - Rates and charges.

- (a) The charges for the city mandated garbage and trash pickup shall be established by the governing body.
- (b) Each subscriber to the city mandated garbage services shall pay their garbage bill to the city or city mandated billing service within ten (10) days of the date such bill is mailed. If such bill is not paid on

time, the city and/or any city contracted private garbage collector shall have no obligation to pick up garbage or trash from such location.

Exemption: Any Saraland resident may apply to be exempted from the city's garbage/trash service if their primary residence is greater than seven hundred fifty (750) feet from the public right-of-way. This is contingent on the resident obtaining permission from the Mobile County Health Department authorizing an alternative waste disposal method for said residence and subsequent approval of the Saraland City Council. Motion was made by Councilmember Biggs, seconded by Councilmember Stanley, to suspend the rules to allow for immediate consideration of the proposed ordinances for the amendment of Section 12-22 and Section 12-32 of the City of Saraland Municipal Code.



City Attorney Andy Rutens was present.


The Council discussed agenda items and general municipal business.
