AMENDMENT TO ORDINANCE 757

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SARALAND, ALABAMA, AS FOLLOWS:

Section 1: That Section 3-3 Official Zoning District Map of the Saraland Land Use & Development Ordinance is hereby amended to read as follows.

Approximately 0.61 acres, a portion of parcel 02 2202091002049.01, petitioned by Sam Heng, as described by the legal description here:

Motion was made by Councilmember Cromer, seconded by Councilmember Moye, to authorize training expenses and adopt a resolution for Kathie Hatchett, Jessie Abbott, Stephanie Anderson, Angela Grantham and Kaylii Porter to attend the 2023 AMCCMA Annual Conference on September 20, 21 & 22, 2023 in Orange Beach, AL. Motion carried.

Motion was made by Councilmember Biggs, seconded by Councilmember Moye, to authorize the mayor to sign the Host Agency Agreement for Alabama Department of Senior Services (ADSS) Senior Community Service Employment Program (SCSEP). Motion carried.

Motion was made by Councilmember Cromer, seconded by Councilmember Moye, to authorize purchase of additional Payroll Software from Kel-Ar Consulting at an annual cost of \$1,692.00. Motion carried.

Council President McDonald advised there is a matter to be discussed in executive session concerning topics of economic development, real estate acquisition and threatened litigation.

City Attorney, Andy Rutens, advised this is appropriate use of executive session as authorized by state law.

Motion was made by Councilmember Biggs, seconded by Councilmember Cromer, to adjourn into executive session with Mayor Rubenstein, Kirby Latham (City Engineer), members from Vallas Realty, Inc. and Andy Rutens to discuss with the city attorney the legal ramifications of and legal options of the city concerning a controversy not yet being litigated but imminently likely to be litigated if the city pursues a proposed course of action, as well as to discuss preliminary negotiations involving matters of trade or commerce in which the City is in competition with private entities or other governmental bodies in Alabama, and upon the advice of the city attorney that the economic recruitment effort would be detrimentally effected and the city's competitive position would be impacted adversely should the discussion take place and be disclosed outside of executive session.

Motion was made by Councilmember Moye, seconded by Councilmember Cromer, to descope the Second Avenue project not to exceed \$50,000, and authorize the mayor to execute a contract with J. H. Adams Construction. Motion carried.

There being no further business to come before the Council, motion was made by Councilmember Cromer to adjourn at 9:11 p.m.
