RESOLUTION 2297

A RESOLUTION OF THE CITY OF SARALAND SUPPORTING THE ALABAMA DEPARTMENT OF TRANSPORTATION'S GRANT APPLICATION TO ASSIST IN FUNDING I-10 MOBILE RIVER BRIDGE AND BAYWAY PROJECT

Support for the ALDOT MEGA Grant Application for the I-10 Mobile River Bridge and Bayway Project

WHEREAS, Interstate 10 is a major East-West corridor for commercial and personal vehicles, and is the only interstate highway that connects the East Coast, West Coast, and Gulf Coast of the United States; and

WHEREAS, the portion of Interstate 10 connecting Mobile and Baldwin Counties was initially built for 30,000 vehicles per day, but now services more than 100,000 vehicles on peak days, with traffic volumes growing steadily and continuously; and

WHEREAS, Mobile and Baldwin Counties are home to significant industry, whose workforce and suppliers rely on Interstate 10 to safely move people and goods across Mobile Bay; and

WHEREAS, the Port of Mobile, the Mobile International Airport, and numerous multimodal hubs all are located on Mobile Bay and frequently utilize Interstate 10 helping to stimulate and drive the economy of Mobile and Baldwin Counties, the State of Alabama and the entire Gulf Coast region; and

WHEREAS, traffic and congestion on Interstate 10 will continue to increase, with negative effects on public safety, commerce, and mobility in the region, if no action is taken; and

WHEREAS, the City of Saraland agrees on the need for a new bridge over the Mobile River and Mobile Bay and a framework to achieve this goal; and

WHEREAS, the City of Saraland recognizes that President Biden and Congress conceived and enacted the Infrastructure Investment and Jobs Act (IIJA), which includes a new discretionary grant program designed to address infrastructure challenges of this type and magnitude, and

WHEREAS, the U.S. Department of Transportation is committed to improving our nation's infrastructure through the National Infrastructure Assistance Program, or "MEGA Grant" program, and

WHEREAS, this program can be a key funding component to address this crucial infrastructure need of local, regional, and national importance,

THEREFORE, **BE IT RESOLVED**, that the City of Saraland supports the Alabama Department of Transportation's application for a MEGA Grant and any other sources of federal funding that may become available, and

THEREFORE, BE IT RESOLVED that the City of Saraland supports the MPO's who are immediately initiating the process within all applicable regulations and bylaws of adding the Mobile River Bridge and Bayway Project in the TIP to move the project forward and to qualify for and apply for the MEGA Grant; and

THEREFORE, BE IT RESOLVED that the City of Saraland supports the MPO's who will finalize the process of including the Mobile River Bridge and Bayway project in their TIPs as soon as possible under the ongoing review and oversight of their respective boards.

RESOLUTION 2300

RESOLUTION DISCLAIMING ANY CLAIM OR INTEREST IN AN EXISTING TRAIL CONNECTING HARRIS AVENUE AND OAK DRIVE

WHEREAS, in September of 1950 the owner of property located in Saraland, Alabama applied for and obtained a subdivision of property otherwise known as the Ed Senack Subdivision; and

WHEREAS, said subdivision contained a dedicated roadway otherwise known as Oak Drive; and

WHEREAS, in July 1954 the owner of property adjacent to the Ed Senack Subdivision subdivided their area of property otherwise known as the Adams and Harris Addition subdivision; and

WHEREAS, the Adams and Harris Addition subdivision contained a dedicated public roadway otherwise known as Harris Road; and

WHEREAS, while the two subdivisions are immediately adjacent, the dedicated Harris Road and the dedicated Oak Drive do not abut one another and are otherwise off-set; and

WHEREAS, over the years, a trail connecting Harris Road and Oak Drive was developed on Lot 36 of the Adams and Harris Addition subdivision; and

WHEREAS, the city has no record of receiving any easement or right of way encompassing this trail across Lot 36 and no evidence or documentation has been discovered illustrating an intent to dedicate that trail for public use; and

WHEREAS, after consultation with the community in and around these two off-set roadways and an analysis of city needs, it is the determination of the city council that it makes no claim to the trail as a right of way or easement, there being no current or anticipated need.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF SARALAND, ALABAMA THAT THE CITY OF SARALAND DISCLAIMS ANY RIGHT, INTEREST OR CLAIM TO ANY EASEMENT OR RIGHT OF WAY OVER AND ACROSS LOT 36 OF THE ADAMS AND HARRIS SUBDIVISION WHICH CONNECTS HARRIS ROAD AND THE DEDICATED OAK DRIVE.
