ORDINANCE 1316

AN ORDINANCE AMENDING CHAPTER 46 OF THE SARALAND CODE OR ORDINANCES CONCERNING PARADES

Whereas, the current Municipal Code of Ordinances addresses the process and procedures as well as the factors to consider in the granting of parade, race and procession permits; and

Whereas, it is the determination of the City that those provisions which are adopted in the 1960's and 1980's should be updated to reflect changes necessitated by the growth of the City; and

Whereas, it is the determination of the City that these changes are necessary for the public health welfare and benefit.

NOW, THEREFORE BE IT ORDAINED BY THE CITY OF SARALAND, ALABAMA THAT CHAPTER 46 ARTICLE III OF THE SARALAND MUNICIPAL CODE IS AMENDED TO READ AS FOLLOWS:

Sec. 46-72. Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Parade means any parade, march, ceremony, show, exhibition, pageant, foot race/walk, or procession of any kind, or any similar display, in or upon any street, park or other public place.

Parade permit means a permit as required by this article.

Sec. 46-74. Same—Application; contents.

- (a) A person seeking issuance of a parade permit shall file an application with the City Clerk on forms provided by her. An application for a parade permit shall be filed with the City Clerk not less than thirty (30) days nor more than one (1) year before the date on which it is proposed to conduct the parade.
- (b) The application for a parade permit shall set forth the following information:
 - (1) The name, address and telephone number of the person seeking to conduct such parade;
 - (2) If the parade is proposed to be conducted for, on behalf of, or by an organization, the name, address and telephone number of the headquarters of the organization, whether the organization is a non-profit organization or not, and the name, address and telephone number of the authorized and responsible heads of such organization;

- (3) The name, address and telephone number of the person who will be the parade chairperson and who will be responsible for its conduct;
- (4) The date when the parade is to be conducted;
- (5) The route to be traveled, the starting point and the termination point;
- (6) The approximate number of persons who, and animals and vehicles which, will constitute such parade; the type of animals, and description of the vehicles;
- (7) The hours when such parade will start and terminate;
- (8) A statement as to whether the parade will occupy all or only a portion of the width of the streets proposed to be traversed;
- (9) The location of any assembly areas for such parade;
- (10) The time at which units of the parade will begin to assemble at any assembly area;
- (11) The interval of space to be maintained between units of such parade;
- (12) If the parade is designed to be held by, and on behalf of or for, any person other than the applicant, a communication in writing from the person proposing to hold the parade, authorizing the applicant to apply for the permit on his behalf.
- (13) If a parade will begin and/or terminate at the Civic Center, the applicant will be required to submit proof of rental of the Civic Center for the hours of the parade, as well as for a period of one (1) hour period prior to commencement of the parade, and for a one (1) hour period after the scheduled conclusion of the parade.

- (14) The applicant shall submit with their application payment of any parade fees established by resolution of the City Council, and applicable to parade events in general. This fee will be refundable should a permit not be granted.
- (c) In addition to the application, an applicant shall pay a fee in the amount of One Thousand And No/100ths (\$1,000.00) Dollars for an organization that is not a recognized non-profit organization based in and operating in Saraland or Five Hundred And No/100ths (\$500.00) Dollars for a recognized non-profit organization based in and operating in Saraland. Any application filed by recognized non-profit organizations not based in and operating in Saraland shall pay an application fee of One Thousand And No/100ths (\$1,000.00) Dollars at the time of the submittal of the application. An application submitted by an organization that is not a recognized non-profit organization and which is not based in and operating in Saraland shall pay an application fee of Two Thousand And No/100ths (\$2,000.00) Dollars at the time of the submittal of the application. If a parade permit is not approved by the City Council, the fee shall be refunded to the applicant.
- (d) The City Council, where good cause is shown therefore, shall have the authority to consider any application hereunder which is filed less than thirty (30) days before the date such parade is proposed to be conducted.

Sec. 46-76. Permit issuance—Standards.

The City Council may issue a parade permit when, from a consideration of the application and from such other information as may otherwise be obtained, it finds that:

- (1) The conduct of the parade will not substantially interrupt the safe and orderly movement of other traffic contiguous to its route;
- (2) The conduct of the parade will not require the diversion of so great a number of police officers of the city to properly police the line of movement and the area contiguous thereto as to prevent normal police protection to the city;
- (3) The conduct of such parade will not require the diversion of so great a number of ambulances as to prevent normal ambulance service to portions of the city other than that to be occupied by the proposed line of march and areas contiguous thereto;

- (4) The concentration of persons, animals and vehicles at assembly points of the parade will not unduly interfere with proper fire and police protection of, or ambulance service to, areas contiguous to such assembly areas;
- (5) The conduct of such parade will not interfere with the movement of firefighting equipment en route to a fire;
- (6) The parade is scheduled to move from its point of origin to its point of termination expeditiously and without unreasonable delays en route;
- (7) The parade is not to be held for the sole purpose of advertising any product, goods or event, and is not designed to be held purely for private profit.

Sec. 46-77. Same—Council approval, grounds for denial.

The City Council shall consider the application for a parade permit at the next regularly scheduled City Council meeting after receiving a full and complete application, as well as the reports from the City officials required to review the application. The City Council will act in a timely manner on the application based upon its determination that all of the necessary or desired information concerning compliance with the standards for permit issuance have been received and reviewed. If the City Council disapproves the application, the City Clerk shall mail to the applicant within six (6) days after the date upon which the application was filed a notice of the City Council's action, stating the reasons for denial of the permit.

Sec. 46-78. Alternative permit; notice of acceptance.

The City Council, in denying an application for a parade permit, shall be empowered to authorize the conduct of the parade on a date, at a time, or over a route different from that named by the applicant. An applicant desiring to accept an alternate permit shall, within seven (7) days after notice of the action of the City Council, file a written notice of acceptance with the City Council. An alternate parade permit shall conform to the requirements of, and shall have the effect of a parade permit under this article.

Sec. 46-79. Notice of permit issuance.

- (a) Immediately upon the receipt of a full and complete application, the City Clerk shall send a copy thereof to the following:
 - (1) The Director of the City Parks and Recreation Department;

- (2) The Chief of Police;
- (3) The City Attorney;
- (4) The Fire Chief;
- (5) The General Manager or responsible head of each public transportation utility, the regular routes of whose vehicles will be affected by the route of the proposed parade.
- (b) Upon the receipt of a parade permit from the City Clerk, the above officials shall diligently review the permit to determine if the requirements of 47-76 are met as it concerns that official's area. After official review, the official shall report their conclusion to the Mayor. Regardless of any determination of the appropriate official, it will be left to the sound discretion of the City Council to determine if the standards as a whole are met and if the permit should be issued.

Sec. 46-82. Permit revocation.

The Mayor shall have the authority to revoke a parade permit upon failure of the applicants or participants to comply with the standards for issuance and the provisions herein set forth and such authority may be delegated to the officer or such other person designated by the Mayor to supervise the parade.

Sec. 46-84. Public conduct during parades.

- (a) No person shall unreasonably hamper, obstruct, impede, or interfere with any parade assembly or with any person, vehicle or animal participating or used in a parade.
- (b) No driver of a vehicle shall drive between the vehicles or persons comprising a parade when such vehicles or persons are in motion and are conspicuously designated as a parade.
- (c) The Mayor or their designee shall have the authority, when reasonably necessary, to prohibit or restrict the parking of vehicles along a highway or part thereof constituting a part of the route of a parade. The Mayor may cause the Chief of Police to post signs to such effect, and it shall be unlawful to park or leave unattended any vehicle in violation thereof.

A RESOLUTION WAIVING PARADE PERMIT FEES FOR THE SARALAND CIVIC FORUM AND THE SARALAND MARDI GRAS ASSOCIATION

WHEREAS, the Saraland Civic Forum has sponsored the Saraland Christmas parade for over twenty years; and

WHEREAS, the Saraland Christmas parade serves a public benefit by bringing individuals to the downtown Saraland area to watch the parade; and

WHEREAS, those parade watchers shop and generate tax revenue for the city; and

WHEREAS, the Christmas parade is a source of great civic pride for the citizens of Saraland; and

WHEREAS, the Saraland Mardi Gras Association sponsors a yearly Mardi Gras parade; and

WHEREAS, the yearly Mardi Gras parade also draws citizens down to the downtown Saraland area; and

WHEREAS, those citizens observing the Saraland Mardi Gras parade shop and generate tax revenue; and

WHEREAS, the Saraland Mardi Gras parade is the source of great civic pride to the citizens; and

WHEREAS, both the Saraland Civic Forum and the Saraland Mardi Gras Association are not for profit organizations that provide a great service and benefit to the city and its citizens; and

WHEREAS, it is the determination of the City Council that the Saraland Civic Forum and the Saraland Mardi Gras Association should have any parade permit fees waived due to their sponsorship of the Christmas parade and the Saraland Mardi Gras parade.

NOW, THEREFORE, BE IT RESOLVED by the City Council for the City of Saraland, Alabama that any parade application and permit fees for the Saraland Civic Forum to undertake and present the Saraland Christmas parade and the Saraland Mardi Gras Association to undertake and present the Saraland Mardi Gras parade are waived until future action of the City Council.
