The additional funds for this project will be provided by doing an amendment to the 2023-2024 budget in the amount of \$139,200.00 out of revised upward projections on income for the current fiscal year, as well as \$107,423.73 which is the amount previously planned to be allocated in the upcoming 2024-2025 budget, therefore there will no funds budgeted in property purchases for the Park and Recreation Department for the 2024-2025 budget.
