


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Saraland, Alabama, as follows:

1. That Joseph "Joe" McDonald received a majority of the votes cast for the office of **Mayor** and is hereby declared elected to that office for the term beginning on the first Monday in November 2025.
2. That Chris Andrews received a majority of the votes cast for the office of **Councilmember, Place No. 1**, and is hereby declared elected to that office for the term beginning on the first Monday in November 2025.
3. That Newton Cromer received a majority of the votes cast for the office of **Councilmember, Place No. 2**, and is hereby declared elected to that office for the term beginning on the first Monday in November 2025.
4. That no candidate received a majority of the votes cast for the office of **Councilmember, Place No. 5**, and that Chris Jessee and Veronica Smith Hudson received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, September 23, 2025 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.




